8. Agree electricity provider for 2020-21

The Clerk has completed a best value exercise – there was one company that was cheaper than the Robin Hood renewal quote, that was EDF energy. However, Robin Hood matched this price and therefore council agreed the new contract.

Account one: standing rate 0.24 p/day and 13.66 per unit Account two: standing rate 0.20 p/day and 13.93 per unit

9. Grounds Maintenance contract for 2020

There is difficulty in arranging new potential providers to come and look at the sites due to the lock down. With this in mind council agreed to approve RPS Grounds Maintenance for another year – costs the same as 2019-20 - £4250 for grass cutting and £400 for hedge cutting.

10. Agree insurance renewal

The renewal form Zurich was £899.54 if council signed to a 5-year deal. The Clerk has completed a comparison and the cheapest provider was Parish Protect who offered a price of £638.40 per year for a 3-year deal. All cover was the same as offered previously by Zurich. Council approved the new provider Parish Protect form 1st June 2020.

11. Tenbury Hospital

Councillors have been made aware that Tenbury Hospital will be closing temporarily due to the current COVID 19 situation. However, there is significant concern that this will lead to the eventual permanent closure of the hospital altogether. There was significant debate about this issue and council decided to make this the focus of the Annual Parish Meeting.

12. Neighbourhood update (Cllr. B. Skidmore)

The main issue raised was the state of the land adjacent to the bridge – the Clerk wrote to the owner following the last meeting, no response received.

13. Village Hall update

There has not been any meeitngs of the parish hall committee due to lock down. However, there is a van parked on the village hall carpark, Cllr. Mr. T. Earp has put a note on it asking for it to be removed.
