

# **Burford Parish Council**

Minutes of meeting on Monday 21<sup>st</sup> January 2019 at 7.30pm at Burford Village Hall

**Public Participation:** - One local resident attended the meeting.

The resident wanted to know why Shropshire Council had approved the Caravan Park. The Chairman explained that both Councillor Earp and he had attended a site meeting also Councillor Huffer. They had met the owners of the site who had explained that the 40 Caravans would be sold to a 3<sup>rd</sup> party who if they wished could let the Caravans out for holidays. The site café would be for residents only. Councillors did make it very clear that they were not happy with regard to linking the site up with the footpath that goes over Farmland. The resident thought it was very sad that Shropshire Council do not listen to residents or councillors, also that it was not acceptable to spend money on consultants with regard to the traffic calming then not proceed.
